1. Introduction:

The MSME – Development and Facilitation Office (MSME-DFO), Thrissur, Ministry of MSME, Government of India proposes to organize Exhibition-cum- Mega Trade Fairs for beneficiaries of the PM Vishwakarma Scheme at Kozhikode from 29.01.2026 to 31.01.2026.

In this regard, the MSME-DFO, Thrissur invites quotation from eligible and experienced agencies for Light and Sound arrangements as per the terms and conditions specified in this Tender Notice. Through this tender, a suitable Bidder will be selected to manage, coordinate, and execute the event in accordance with the scope of work and specifications provided in the document.

Tender participants must fulfil the eligibility criteria prescribed herein to qualify for participation in the tender. Bidders shall ensure that all required supporting documents, as specified in the Tender Document, are submitted in full. Bids submitted without the requisite supporting documents shall be liable to rejection.

5. Evaluation Criteria

A committee of Officers appointed by Director, MSME-DFO, Thrissur, Kerala (competent authority) will examine the Quotations to determine whether the eligibility criteria submitted is as per the requirements in the Tender document; whether the documents have been properly signed and whether the Quotation is generally in order. Any quotation found to be non-responsive for any reason or not meeting the eligibility criteria specified in the Tender document will be rejected by the Authority and will not be included for further consideration.

6. Selection Process

The selection process for the Agency will be as below:

1. Short listing of Agencies based on the eligibility criteria on receipt of Financial Bids as per the Tender document.
2. Sealed **Annexure II - "Financial Bid" with Annexure I - "Covering Letter", "Covering Envelope A"** has to be submitted by the Agencies by post/by hand to *The Director, MSME – Development and Facilitation Office, Thrissur, Ayyanthole P.O., Kanjani Road, Thrissur - 680003* on or before 20.01.2026 before 5.00 pm.
3. All bids received in complete and within the stipulated deadline shall be opened by the Selection Committee at MSME- DFO, Thrissur. Lowest bid-L1 (**consolidated rate**), found suitable as per the specifications required, shall be referred by the Selection Committee to the Competent Authority for final decision.
4. **The decision of the Competent Authority viz. Director, MSME-DFO, Thrissur, in this regard, shall be final and it will not be challengeable at any point of time.**
5. The competent authority reserves the right to cancel this tender at point of time prior to the commencement of the Programme and this cannot be challenged by the bidders.

Some of the activities indicated to be carried out by MSME-DFO, Thrissur subsequent to the receipt of the responses are indicative only. Director, MSME-DFO has the right to continue with these activities, modify the sequence of activities, add activities or remove some of the activities, as found to be in the best interests of the Programme. Wherever not specifically mentioned, the GFR, and other Government of India guidelines will be followed in this tender procedure.


7. Scope of Work
