The tenders addressed to the Joint Director and HoO MSME-DFO, Kanjany Road, Ayyanthole, Thrissur - 680 003 and superscribed with "Tender for disposal of miscellaneous and other office stores" may be sent by registered post or in person within the time shown above.
3. CGST/SGST tax at usual rates will have to be paid extra.
4. The tenders will be opened on the same day i.e. 03.08.2022 at 3.30 PM at MSME-DFO , Thrissur in the presence of the tenderer or their representatives who may be present.
5. The successful bidder will have to remit the sale proceeds and CGST/SGST, Cess, etc. as applicable within 10 days by way of crossed demand draft in favour of Assistant Director (Admn), MSME-DFO, Thrissur payable at SBI, Thrissur, failing which the sale will be cancelled.
